What is PerioStom?

PerioStōm is a non-drug treatment to support gum health. The key ingredient, Chitosan, addresses the 3 main causes of gum disease, all while being completely biocompatible.

Why do I need PerioStom?

Your dentist/hygienist has diagnosed you with periodontitis/gingivitis, which is an inflammatory condition. To help treat the inflammation, your hygienist will place PerioStōm in the infected area(s).

Is PerioStom safe to use around my dental implants?

Yes, PerioStōm is safe to use around dental implants.

Who can benefit from PerioStom?

Any patient with gingival inflammation and/or active gingival infection.

What are the age limits for PerioStōm?

Because PerioStōm is extremely biocompatible and all-natural, it does not have any age restrictions.

What procedures can PerioStom be treatment planned with?

PerioStōm can be used as an adjunctive therapy with prophylaxis (1110), gingivitis (4346), periodontal maintenance (4910), SRP (4341 & 4342), and scaling and debridement of a single implant (6081).

How many sites should PerioStom be placed in?

PerioStōm is a prescribed wound dressing that is treatment planned at the discretion of the licensed clinician (dentist or hygienist) based on the examination and clinical findings of each individual patient.

Can a patient have PerioStom and lasers on the same treatment plan?

Yes, PerioStōm can be used in conjunction with laser therapy. PerioStōm is placed in the affected area(s) after SRP and laser therapy to promote wound healing.

What is the CDT code for PerioStom?

D4381. This is a per tooth code. The fee submitted for a tooth should include all sites being treated on each tooth.

Is PerioStom covered by insurance?

Each insurance plan is different; verify benefits to see if PerioStōm is a covered benefit by the patient's plan.

What are some words to use when discussing PerioStom with patients?

"Active infection", "inflammation", "wound dressing", "prescribed", "3-pronged approach to supporting gum health by addressing bacteria, biofilm, and inflammation"
